

Golf Cart Rental Agreement

Golf Cart Rental times are as follows: Check-in: 11:00 AM to 5:00 PM. Please return your golf cart by 11:00 AM.

Rates are subject to change without notice.

All golf cart drivers must be registered at the front desk and this golf cart agreement signed by all drivers. You must also provide a valid driver's license and proof of full coverage insurance at the time of rental.

If you have reserved the golf cart for multiple days, the golf cart must be stored at your site in the Resort. Do not leave the keys in the cart.

Rules: Initial each rule

- _____ Renter shall abide by all rules and regulations governing the use of the golf cart. The renter is responsible for all actions of all passengers and persons operating the cart with their express or implied permission.
- _____ Renters must be at least 21 years of age with a valid driver's license and a major credit card. Drivers must be at least 18 years of age with a valid driver's license.
- _____ Under NO circumstances is anyone without a valid driver's license allowed to operate the golf cart.
- _____ Golf cart Rentals are NON-TRANSFERRABLE.
- _____ Limit of 4 licensed drivers per golf cart. No lap riding, sitting on the dash, or standing at the rear or sides of the cart is permitted. Passengers must be seated at all times when the cart is in motion.
- _____ Keys must not be left in the golf cart when not in use. Always make sure that the brake is fully engaged when parked. Do not park the golf cart facing in any downhill position as it may roll away.
- _____ Golf carts must follow the speed limits. Horseplay, racing, or other misuse of the cart will not be tolerated.
- _____ Pedestrians, pedal karts, bikes, and wheeled toys always have the right of way.
- _____ Under no circumstances may the operator be under the influence of any intoxicating substance (i.e., drugs, alcohol, etc.). Doing so will result in the revocation of the person's renting and operating privileges for the rest of their visit.
- _____ Golf carts operated after sunset must have their lights on.

- _____ Golf carts cannot be operated during quiet hours (11 PM to 7 AM).

_____ Golf carts must be returned at the designated time set forth above. Late returned carts will be charged \$25 every 30 minutes past the designated time.

_____ Golf carts are NOT street legal, and they are to be operated on campground roads, not on trails or grass areas. Golf carts are not allowed outside the campground on public roads, highways, or past the main entrance.

_____ Golf carts are never to be ridden through any creek, lake, or body of water. Doing so will terminate the golf cart agreement without a refund. Damages may be assessed.

_____ Please report any malfunction to management immediately.

_____ Golf carts are NOT pet friendly.

_____ Lost key fee of \$25.

_____ Golf cart must be stored in a safe spot at the renter's site in the Resort if the golf cart is reserved overnight.

_____ Golf Cart must not be charged for longer than two hours at any given time as the battery could become severely damaged.

I have read and agree to the terms of this agreement and authorize my credit card to be charged according to the charges due as listed in this agreement. I hereby state that I have insurance coverage and agree to pay for any damage done to the cart while rented. I will hold harmless Coachella Lakes RV Resort from and against any and all liability, including bodily injury and property damage arising out of the use or operation of the golf cart by myself or anyone using or operating the golf cart during my Rental period. I am at least 21 years old. I have received a copy of this Agreement and agree to all terms and rules contained herein.

2. Lessee shall return the equipment to the place of initial rental no later than the date and time specified above (LESSEE SHALL CONTACT LESSOR IF AN EXTENSION OF TIME IS DESIRED) or upon Lessor's demand, therefore. The equipment shall be returned in the same condition as when received, ordinary wear accepted. Lessor will have sole discretion in determining charges for cleaning, damage, and/or loss of use.

3. Lessee shall pay to Lessor, upon demand, rental for the equipment at the rates provided above until the equipment is returned to Lessor. Nightly rates will apply unless other arrangements are made with Lessor in advance. Nightly rates will apply if the equipment is kept after the scheduled return date.

4. Lessee shall reimburse Lessor, upon demand, for the loss of, or any damage to the equipment while it is rented to Lessee and for all costs and expenses, including reasonable attorney's fees, incurred by Lessor in collecting and the amount owing by Lessee hereunder or in otherwise enforcing Lessor's rights hereunder.

5. Lessee shall indemnify and hold Lessor harmless from and against any and all liability, including bodily injury and property damage, arising out of the use or operation of the equipment by Lessee or anyone using or operating the same with Lessee's express or implied consent; provided, however, that Lessor shall be responsible for loss or damage resulting from Lessor's sole negligence.

6. Lessee shall abide by all the rules and regulations of Lessor governing the use of the equipment.

7. Lessee shall not assign this Rental Contract or sublease the equipment.
